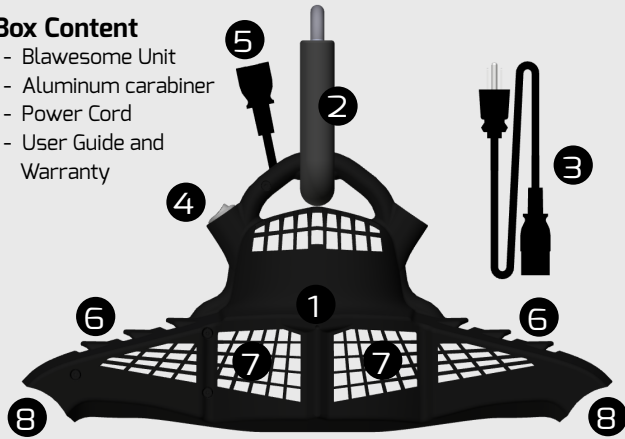

Features

Blawesome Wetsuit Dryer is an innovative product that helps you dry your equipment even in adverse condition such as cold and humid winter days. You can find listed below its main features:

- Blawesome Unit:** A powerful centrifugal blower is the heart of Blawesome. It blows up to 290 m³/h of warm air in every direction to speed up drying.
- Aluminum Carabiner:** to hang your unit.
- Power cord:** it will vary depending on your region.
- Natural/Warm air switch:** "I" for warm air; "O" for natural air.
- Power inlet:** connect here the power cord.
- Shoulder outlet:** drives air to the shoulders
- Chest and back air outlet:** drives air to the chest and back. Most of this air will flow through the legs as well (for full suits)
- Arms outlet:** drives air to the arms and partially to the legs.

Quick start

- Press the switch to "I" position for warm air, or "O" for natural air
- Hang your suit from Blawesome. If it is a wetsuit, make sure you left it dripping water for +15 minutes before hanging.
- Plug the power cord. Blawesome fan is now blowing air inside your suit.

3. Warranty Information

1. Blawesome Ventures warrants to the original purchaser that Blawesome products are free from defects in material and workmanship under normal use and service for the period commencing upon the date of purchase from an authorized dealer and continuing for the following period of time after that date for (1) Year.

2. This Limited Warranty is conditioned upon proper use of the product by the Purchaser. This Limited Warranty does not cover: (a) defects or damage resulting from accident, misuse, abuse, neglect, unusual physical or electrical stress, modification of any part of the product or cosmetic damage; (b) equipment that has the serial number removed or made illegible; (c) all plastic surfaces and other externally exposed parts that are scratched or damaged due to normal use; (d) defects or damage from improper testing, operation, maintenance, installation, adjustment or service of the products.

During the applicable warranty period, Blawesome Ventures will repair or replace, at Blawesome Ventures's sole discretion without charge to the purchaser, any defective component part of the product. Blawesome Ventures may, at Blawesome Ventures's sole discretion, use rebuilt, reconditioned, or new parts or components when repairing any product or replace a product with a rebuilt, reconditioned, new or comparable product.

Some jurisdictions do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. This warranty gives you specific legal rights, and you may also have other rights which vary under local laws.

Return Information

- A return merchant authorization number must be obtained from your local Blawesome representative.
- Customer may be required to provide pictures of the product and/or defect of sufficient quality that allow a service representative to identify the origin of the reported defects. Blawesome Ventures, may contact the Customer more than once for any further clarification if needed.
- A copy of the original sales receipt must also be included for the equipment to be repaired under warranty
- The faulty equipment must be packed in its original packaging. One additional outer layer of packaging must be included to ensure product safety. Failure to do so may inadequately protect the equipment in transit and therefore jeopardize the warranty.
- Blawesome Ventures will not accept COD shipments and no call tags will be issued for merchandise return.
- Blawesome Ventures will not return repaired merchandise to customers by priority service except by written request at the customer's cost. Requests must be submitted in writing with returned merchandise.
- The defective Blawesome Ventures equipment should be sent freight prepaid with the return merchant authorization number printed clearly on the outer packaging and original sales receipt enclosed to your local service center.
